A late payment fee of \$25.00 and an 18% finance charge (APR) will be assessed on all payments that arrive more than ten (10) days past their due date. A \$25.00 fee is charged on all returned checks.

Whereas, Student is in the process of enrolling for a course of study at Barton College, and hereby requests that Barton College extend credit to Student at various times during the academic year to cover Student's cost of tuition, fees, room, board and any other miscellaneous charges and/or fines.

Student acknowledges that Student's portion of tuition, fees, room and board charges may be dependent upon the outside financial aid received by Student. Therefore, Student agrees to take all necessary actions to insure that Student receives all outside financial aid awarded to Student, and Student agrees to apply all outside financial aid received by Student to Student's costs of tuition, fees, room, board and miscellaneous charges and/or fines.

Student acknowledges that He/She shall be liable for the total cost of tuition, fees, room, board and miscellaneous charges and/or fines incurred by Student while attending Barton College.

Student hereby authorizes the keeping by Barton College of accounts for Student to cover the costs of tuition, fees, room, board and miscellaneous charges and/or fines, and the financial aid awarded to Student, said accounts to be evidenced by periodic statements sent to Student. Student hereby agrees to honor the terms of payment associated with these accounts as set forth in any payment plan arrangement and/or periodic billing statement made with or sent to Student.

At the option of the Lender, the maturity date of this Agreement will be accelerated and the entire unpaid balance of this Agreement may become immediately due and payable if the Student: (1) fails to comply with the terms and conditions of this Note and/or the Student's payment plan; or (2) terminates enrollment; or (3) initiates or is subject to bankruptcy proceedings; or (4) is found to have falsified information in order to obtain this Agreement.

In the event of Student's default, Student agrees to pay the Lender all reasonable attorney's fees and other costs and charges necessary for the collection of any amounts not paid when due.

All terms and conditions of this Agreement are jointly and severally liable to Student/Maker and Co-signer.

The Student has the right to prepay all or any part of the total balance due without penalty.

The delay in enforcement or other waiver of any of the provisions of this Agreement shall not constitute a waiver of enforcement of said provision or other provisions in the future.
